

Grant, Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement

THIS MUST BE CAREFULLY READ AND SIGNED. IN CONSIDERATION of being permitted to participate, compete in any way in football camps (e.g. 7 on 7 competition), training activities, and related events (collectively, "**Football Camp**") operated by Grier7, LLC ("**G7**"), I agree, on behalf of myself and my family members, parents, heirs, executors, administrators, next of kin, representatives, and affiliates as follows:

1. GRANT OF RIGHTS. I acknowledge and agree that the Football Camp and all related activities may be videotaped, photographed, or otherwise recorded. For good and valuable consideration, including any exposure and public recognition I may receive from participating in G7's Football Camps, receipt of which is hereby acknowledged, I hereby grant to G7 and the "G7 Designees" (as defined below) the irrevocable, transferable, perpetual, worldwide, and royalty-free right, but not the obligation, to photograph, film, tape, and record (including video recording, audio recording, digital or electronic recording, etc.) me and my participation in, or association with, the Football Camps (collectively "**Recordings**") and to use my use and utilize my name, persona, biographical material, nickname(s), initials, voice, images, autograph/signature, portrayals, actions, likeness (including, without limitation, my likeness on or in Recordings), jersey number, performances, appearances, and other personal indicia (collectively, "**Likeness**") in connection with the reproduction, distribution, advertising, broadcasting, exhibition, promotion, and other exploitation of the Football Camp, Recordings or any part thereof by any means and in any medium now known or hereafter devised in all languages, including, without limitation, on Chad Grier, Will Grier, and/or the G7 Designees' social media platforms (e.g. Instagram, Twitter, Facebook, etc.) as well as any social media platforms created for the Football Camp (the Recordings, appearance, Likeness, and the results and proceeds thereof are collectively, the "**Materials**"). I understand, acknowledge and agree that G7 shall be the sole and exclusive owner of all rights, title, and interest in and to the Material, including, but not limited to, any rights of intellectual property (e.g. copyright) and that I shall have no interest or ownership in any such Materials. I hereby waive the opportunity and right to inspect or approve any use of the Materials by G7, the G7 Designees, or any of the uses to which it or they may be put. I agree that I shall not receive and I hereby waive any right to any and all claims for consideration of any kind arising out of any use of any of the Materials and represent that no other party's consent, authorization, release, or compensation is required to grant the rights herein. I hereby waive and release any and all claims (i) to any and all proceeds and revenues derived from any use of the Materials, agree that such proceeds and revenue are the sole property of G7, and agree that G7 and the G7 Designees shall have the right, without my consent to assign, license, or otherwise transfer, in whole or in part, and exclusively or non-exclusively, any of the rights granted in this Section 1, (ii) for defamation, violation of any moral rights or rights of copyright, privacy, personality and/or publicity, and (iii) in connection with the exercise of any and all rights granted by me herein.

2. ASSUMPTION OF RISK/ ABILITY TO PARTICIPATE. My choice to participate in the Football Camps is knowing, voluntary, and made for my personal enjoyment and benefit. I understand that participation in the Football Camps involves inherent risks, including but not limited to, dangers of accidents, dangers involved in travel, emergency treatment, property loss or damage, serious personal and/or bodily injury, concussions, mental impairment, dangers associated with participating in the Football Camps during the COVID-19 pandemic (e.g. contracting COVID-19 or other diseases such as the flu or legionnaires disease), death, and severe personal and economic losses. These may result not only from my own actions, inactions, or negligence, but also from the actions, inactions, or negligence of others, or the condition of the facilities, or equipment. I hereby assume all such risks and the inherent risks involved in the Football Camps and any risks inherent in any other activities in connection with the Football Camps in which I may voluntarily participate. I assume full responsibility and risk of bodily injury, death, and/or property damage due to my own negligence as well as the negligence of any of the "G7 Designees" (as defined below). I acknowledge and agree that neither G7 nor any of the G7 Designees have made any representations and/or warranties of any kind regarding my qualifications, ability, or fitness to participate in the Football Camps hereunder and that G7 and the G7 Designees are relying on me to make the determination that I am capable of undertaking the activities and participating in the Football Camps.

3. RELEASE FROM LIABILITY, WAIVER, AND COVENANT NOT TO SUE. I HEREBY IRREVOCABLY WAIVE, RELEASE, AND FULLY AND FOREVER DISCHARGE, G7, PROMOTERS, PARTICIPANTS, VOLUNTEERS, EMPLOYEES, CONTRACTORS, ORGANIZATIONS INVOLVED IN THE FOOTBALL CAMPS, SPONSORS, ADVERTISERS, PRODUCTION CREWS, VENUE PROVIDERS, OWNERS AND LEASEES OF PREMISES USED TO CONDUCT THE FOOTBALL CAMPS, EMERGENCY PERSONNEL, CONSULTANTS, AND OTHERS WHO GIVE RECOMMENDATIONS, DIRECTIONS, OR INSTRUCTIONS FOR THE FOOTBALL CAMPS, AND EACH OF THEM AND THEIR RESPECTIVE DIRECTORS, OFFICERS, MEMBERS, FAMILY MEMBERS, AGENTS, MARKETING REPRESENTATIVES, MANAGERS, ATTORNEYS, ACCOUNTANTS, EMPLOYEES, AND CONTRACTORS (COLLECTIVELY, "**G7 Designees**") FROM ANY AND ALL CLAIMS, ACTIONS, SUITS, COSTS, LIABILITIES, JUDGEMENTS, OBLIGATIONS, LOSSES, PENALTIES, EXPENSES (INCLUDING WITHOUT LIMITATION, LEGAL FEES AND EXPENSES) AND/OR DAMAGES OR WHATSOEVER KIND AND NATURE (COLLECTIVELY, "**Claims**") THAT I AND/OR MY REPRESENTATIVES, PARENTS, HEIRS, EXECUTORS, ADMINISTRATORS, NEXT OF KIND, AND/OR AFFILIATES HAS OR MAY HAVE AGAINST G7 AND/OR THE G7 DESIGNEEES ARISING FROM OR RELATED TO MY PARTICIPATION IN THE FOOTBALL CAMPS, AND HEREBY IRREVOCABLY COVENANT AND AGREE NOT TO SUE G7 AND/OR ANY OF THE G7 DESIGNEEES FROM ANY MATTER RELEASED HEREBY, ANY CLAIMS, INCLUDING BUT NOT LIMITED TO, INJURY, ILLNESS, DAMAGE, LOSS OR HARM TO ME OR MY PROPERTY, CONCUSSIONS, MENTAL IMPAIRMENT, OR MY DEATH OR DISABILITY, HOWSOEVER CAUSED, WHETHER CAUSED BY THE NEGLIGENCE OF G7 AND/OR G7 DESIGNEEES, AND/OR OTHERWISE RESULTING FROM OR ARISING OUT OF, OR IN CONNECTION WITH, MY PREPARATION FOR, TRAVEL, AND/OR PARTICIPATION AND/OR APPEARANCE IN THE FOOTBALL CAMPS AND THE ACTIVITIES ASSOCIATED THEREWITH.

4. INDEMNITY. I hereby agree to defend, indemnify, hold harmless, and reimburse G7 and G7 Designees for any and all matters released herein and any

Claims, including but not limited to injury, accident, concussions, mental impairment, illness, damage, loss or harm to me or my property or my death or disability, however caused, whether caused by the negligence of G7, G7 Designees, or otherwise.

5. MEDICAL TREATMENT. I hereby consent to receive medical treatment, which may be deemed necessary in the event of any injury, accident, concussion, mental impairment, illness, and/or medical emergency resulting from or in connection with my participation in the Football Camp and understand that I am solely responsible for any and all costs related to such medical treatment, medical transportation, and/or evacuation.

6. ENFORCEABILITY. I agree that this GRANT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT extends to all acts of negligence by G7 and G7 Designees, including improper emergency treatment, and is intended to be as broad and inclusive as is permitted by the laws of the State in which the Football Camp is conducted and that if any portion thereof is invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I REPRESENT AND WARRANT THAT I (A) HAVE READ THIS GRANT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, (B) UNDERSTAND THE PROVISIONS SET FORTH HEREIN, INCLUDING THE RELEASE FROM LIABILITY, WAIVER, AND COVENANT NOT TO SUE, (C) AGREE THAT THE TERMS ARE FAIR AND REASONABLE, AND (D) AM SIGNING IT FREELY AND VOLUNTARILY WITHOUT COERCION AND BASED ON MY OWN JUDGEMENT AND NOT IN RELIANCE UPON ANY ASSURANCE, GUARANTEE, REPRESENTATION, OR PROMISE MADE BY G7 OR ANY OF THE G7 DESIGNEES.
